Notice about change in the Board of Directors



Shri Sudhir Shyam is a 1999 batch Indian Economic Service (IES) officer. He has done his graduation in Economics from Delhi University, post graduation and Master of Philosophy from Jawahar Lal Nehru University (JNU). He worked as Assistant Director in the Department of Economic Affairs in the Project Management Unit, during the period from 2001 to 2004, in the Internal Trade Division of Department of Consumer Affairs till the end of 2008, as Deputy Secretary in the Ministry of Rural Development for four years (2009-2012). On completion of his tenure, he joined the Department of Economic Affairs in 2013 and was tasked with human resource management of Indian Economic Service Officers. He later joined Department of Financial Services in 2015 and is currently working as Director in the Department of Financial Services (DFS). His responsibilities, inter alia, include handling of select banking legislations, agency

business by banks, matters relating to international cooperation in the financial sector, etc. He has earlier served on the Board of Directors of State Bank of Patiala from 2015 till the merger of State bank of Patiala with State Bank of India.
