BRIEF PROFILE OF SHRI SURESH KISHINCHAND KHATANHAR

Shri Suresh Khatanhar is a career banker with a total experience of 38 years in almost all areas of commercial banking in Public Sector Bank, New Generation Pvt. Sector Bank and Universal Bank. He started his banking career with Dena Bank and handled branch banking, Credit Appraisal/ Monitoring, Stressed Accounts, represented the Bank at BIFR/AAIFR hearings and handled all HR related work at centralized HR department of the Bank.

Later, joined IDBI Bank as Senior Relationship Manager and served the organization in various capacities including as CGM & Head-Internal Audit, Chief Risk Officer and Chief Compliance Officer. As Executive Director, he was assigned the responsibilities to head Priority Sector business vertical of the Bank. The Bank could achieve the PSL targets for the first time in the Bank. Additionally, handled the responsibility of Retail Banking of 4 large zones. Subsequently was entrusted with responsibility of spearheading the Corporate Banking Business as well as Trade Finance Business of the Bank.
